DISCONTINUATION & FORCE MAJEURE NOTICE

Subject: OXY-PRO SELF RESCUER 30MIN

Dear Customers and Colleagues,

As you are aware and in response to geopolitical events, several governments have implemented sanctions and export controls restrictions which impact multiple industries in Russia and Belarus, including, among others, aerospace, refining, and electronics. In order to ensure compliance with all applicable laws and regulations relating to these sanctions and restrictions, Honeywell is unable to deliver OXY-PRO OXY-PRO SELF RESCUER 30MIN (detailed part number list is below) and to perform any of contractual obligations in respect of the manufacturing and delivery thereof, which constitutes a Force Majeure event under Honeywell terms and conditions of sale that may be found at https://sps.honeywell.com/us/en/support/safety/legal-documents/hppe and regulations.

Honeywell has tried to resolve without success this forced discontinuation caused by the inability of Honeywell to source a critical assembly component due to a change in legislation constituting a force Majeure event.

Therefore, this notice of discontinuation & Force Majeure is effective immediately. Honeywell discontinues taking any new orders for OXY-PRO SELF RESCUER 30MIN (detailed part number list is below).

This Force Majeure Event will prevent Honeywell from providing aftermarket maintenance that requires exchange of the K02 cartridge.

If warranted goods are returned to Honeywell during the period of coverage, Honeywell will repair or replace, at its option, without charge those items that Honeywell, in its sole discretion, finds defective. Notwithstanding the foregoing, in the event of a product end-of-life or obsolescence, or inability of Honeywell to manufacture or source materials or component parts for a product, for whatever reason, and/or any associated last-time buy in relation to a product (an "Obsolescence"), Honeywell shall engage in commercially reasonable efforts to repair or replace products in accordance with the terms of its standard warranty, but in no event shall it be liable if it is unable to do so due to the Obsolescence. The foregoing is buyer's sole remedy and is in lieu of all other warranties, expressed or implied, including those of merchantability and fitness for a particular purpose. In no event shall Honeywell be liable for consequential, special, or indirect damages.
